New Feature - Legislators Tab!

We're thrilled to introduce our new legislators tab, where you can see which bills your representative is supporting at a glance! The list displays how many and which bills each lawmaker is sponsoring and cosponsoring, and is organized by chamber (House, then Senate), then affiliation (Democrat, Republican, Independent), then alphabetically by last name. New Bills:

<u>S.3892 - Conservation Reserve Program (CRP) Improvement Act of 2022</u>: This bipartisan bill, introduced on 3/22 by Senators Thune (R-SD) and Klobuchar (D-MN), would amend the CRP, including by increasing the CRP annual payment limit from \$50,000 to \$125,000; providing cost-share for the establishment of grazing infrastructure - including fencing and water distribution - on CRP contracts if grazing is included in the approved conservation plan; and through other adjustments. H.R.7019 / S.3803 - Rural Prosperity Act of 2022: This bipartisan, bicameral bill, introduced on 3/9 in the House by Rep. Craig (D-MN-2) and 3/10 in the Senate by Sen. Kelly (D-AZ), would establish an Office of Rural Prosperity within the White House to carry out a comprehensive strategy for rural development, addressing agriculture-related issues including preserving family farms, increasing employment opportunities in agriculture, and removing barriers to rural prosperity, among others. <u>S.3743 - Recycling and Composting Accountability Act</u>: This bipartisan bill, introduced on 3/3 by Sen. Carper (D-DE), would require the EPA to submit a report to Congress on the capability of the US

to implement a national residential composting strategy, and to collect and publish data on composting and recycling rates across the country. See <u>Tracker - Ancillary tab</u>.

Reintroduced Bills:

H.R.6935 - Voluntary Grazing Permit Retirement Act: This bill, reintroduced on 3/3 by Rep. Smith (D-WA-9), would allow ranchers who hold grazing permits on federal lands to voluntarily retire their permits in exchange for payment. The managing federal agency (USDA or DOI) would then be required to permanently retire the allotment covered by the permit from grazing activity. See Tracker-Ancillary tab.

Bills Advancing through Congress:

H.R.4521 - America COMPETES (Creating Opportunities for Manufacturing Pre-Eminence in Technology and Economic Strength) Act of 2022: This bipartisan bill, introduced by Rep. Eddie Bernice Johnson (D-TX-30), is largely aimed at increasing American economic competitiveness and supply chains, but includes international development assistance to employ "agricultural production practices that reduce poverty while improving soil health". The bill is currently being considered in the Senate. See <u>Tracker - Ancillary tab</u>.

Hearings Held:

A 2022 Review of the Farm Bill: The Role of USDA Programs in Addressing Climate Change:

This hearing, held on 3/16/2022, featured testimonies from farm groups, educational institutions and other orgs on how Farm Bill programs can help producers implement conservation practices. Groups called for <u>more funding for conservation programs</u>, conservation technical assistance to allow for more ag involvement in climate efforts, adjustments to crop insurance, and <u>other key issues</u>.

<u>A 2022 Review of the Farm Bill: Rural Development</u>: During this 3/8/2022 hearing, Undersecretary for Rural Development Xochitl Torres Small spoke to Congress about investing in broadband, reducing barriers to reach historically underserved communities, building supply chain resilience, and supporting producers with climate-smart solutions.
